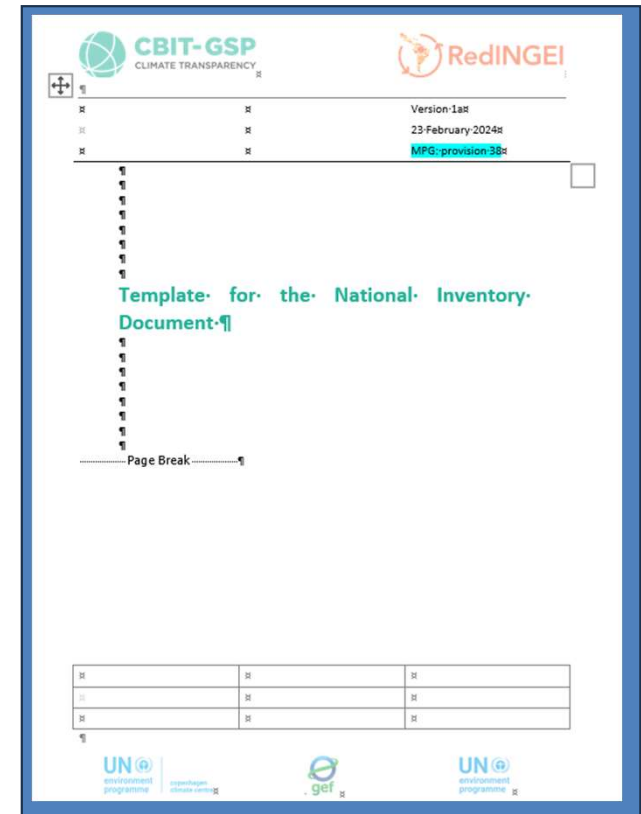


Introduction to the CBIT-GSP NID template

The CBIT-GSP NID template provides a format for the NID and for the chapter on inventory that can be included in national communications, BURs or BTRs.

The proposal includes a general structure for the NID and a description of the minimum contents that each section should address (in square brackets []), including tables and figures.

Each section (where applicable) includes a remarked number in turquoise that refers to the MPGs arrangement implemented and, if relevant, the flexibility offered to countries in need.

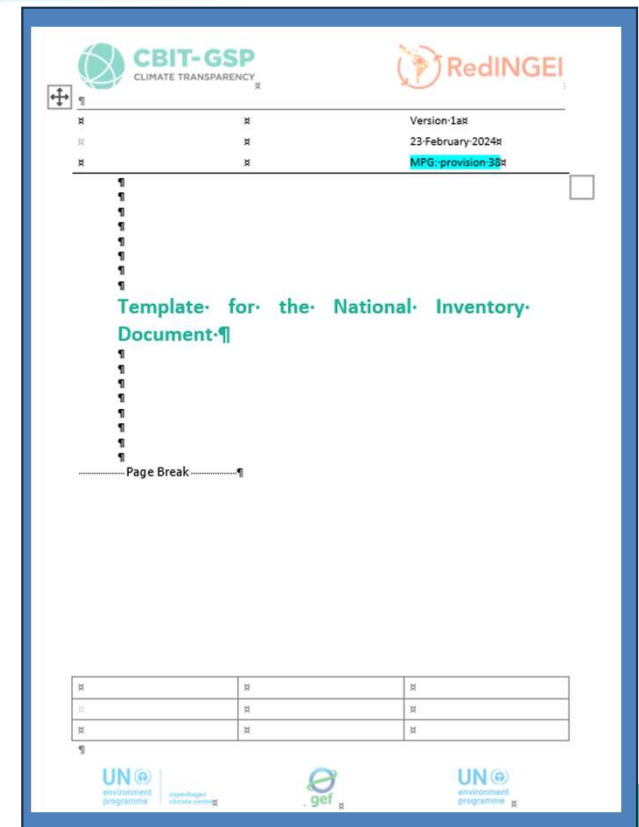
